## E-Safety Advice for Parents, Carers & Families

## What do we do at Orchard Academy to promote E-safety?

- Lockdown has led to children spending more time online and we are aware there has been an increase in online related issues. We will begin our lessons in September by re-establishing safe internet use.
- We promote E-safety through our Computer Safety and Acceptable Use Policy, ratified by our Governors.
- All children sign our E-safety code of conduct and these are displayed in every classroom.
- We provide parent training to support parents at home. These sessions are delivered by Thames Valley police.
- Our Safer Internet Day (February 9<sup>th</sup> 2021) teaches children about staying safe with technology.
- We discuss E-safety in assemblies throughout the year and address issues as they are raised.
- All reported incidents are investigated and dealt with by our E-safety leads.
- All computers are installed with Net Support software, which allows all computer usage to be monitored by the school. Inappropriate searches are recorded and automatically reported to the SLT.
- We provide a list of useful websites on our website, supporting parents and children in learning about E-safety. See the 'E-safety page under the 'Parents tab on our website to explore these.

## What can you do at home to promote E-safety?

- Ensure your child has access to appropriate internet content - for example, Facebook is for children of 13 and older.
- Visit the E-Safety websites available through the Academy website.
- Teach your child strategies to deal with issues - this might be as simple as questioning an alert on a computer with adults.
- Encourage your child to only share their personal information with people they know in real life. Teach them the risks and dangers of sharing information like this.
- Consider where you place your computer, allowing you to keep an eye on content and time spent with technology.
- Consider using filtering software to block unwanted content. In addition to filtering, remember that discussion with your child, and involvement in their internet use, are both effective ways to educate them about the internet.
- If your child is being bullied online, save all available evidence and know where to report the incident, for example to the school, service provider, or the police if the law has been broken.
